#### INFRASTRUCTURE

Collaborate with city and county staff on plans, designs, and policies that support walking and biking for transportation, such as the Richmond Bicycle Master Plan and the Chesterfield County Bikeways and Trails Plan.



#### FUNDING

Work with elected officials and community residents through our Connect RVA campaign to prioritize funding for infrastructure improvements that make walking and biking safe and easy.



#### GRASSTOPS

Educate elected officials and other decision makers on the importance of connecting our communities with safe and comfortable places to bike and walk, and support their decisions to make this vision a priority.



#### GRASSROOTS

Develop community residents into effective advocates for comfortable and connected walking and biking infrastructure in their neighborhoods through our Bike Walk RVA Academy – an 8-week advocacy training program.




### CELEBRATE


# Changing the public narrative



"The road is nearly impossible to cross during high-traffic hours. I rarely let my children walk with me – you can't just 'cross' the street, you have to run."

Each year in the U.S., Hispanic communities experience 3.6 more total crashes per mile of street compared with White communities.



"Not many people walk or bike around here, but I think more people would if there wasn't traffic zooming by at 60 miles per hour. If people could feel more protected, I think that would change. We need sidewalks, and we need them soon."

### Support the Bikeways and Trails Plan

The new Bikeways and Trails Chapter of the Chesterfield County Comprehensive Plan is up for adoption before the end of the year. It passed through the Planning Commission on Ocotber 20 with a 4-1 vote and goes before the Board of Supervisors for public hearing and vote on November 18.

When adopted, this plan will lay the groundwork for over 360 miles of new on-street bikeways and paved trails, to be build out over time as funding is available and with development.

On Nov. 18, the Board of Supervisors will hold a public hearing on a \$360 million countywide bike and trails plan.

Some critics have called the plan a progressive entitlement and biking a privileged activity.

To residents living along Jeff Davis with no means of transportation, like Marvin Cherry, it's a matter of survival. Cherry said he would get himself a bike, but, without sidewalks and trails, he considers it too dangerous to ride one.

"Ain't no way to ride a bike here; the roads are not safe for that," he said. "This is Chesterfield — I think they could do a lot better with the transportation, because many people can't afford a car."
